



## INDEMNITY & LIABILITY WAIVER FORM

In consideration for my being able to participate in the BSA surf coaching course (hereinafter the "COURSE") I state I am a competent swimmer, familiar with all the hazardous conditions which may exist in connection with surfing courses, medically and physically fit and able to participate in the COURSE.

I am aware that there are hazards that may exist in connection with my participation in such COURSES and I voluntarily participate in these activities with knowledge of those hazards. This includes the use of flat water equipment such as Indo Boards and Stand Up Paddle Boards. I further state that whilst I accept that Cressey's Surf Academy will take all possible due care and attention during the delivery of the BSA surf coaching course, I hereby assume the risk for any injury, damage or death that I may sustain to property or person in connection with my participating in the COURSE and fully release and indemnify Cressey's Surf Academy from all claims, damages, actions, suits or judgments that may result from any type of injury, damage or death that I may sustain to property or person while participating in the COURSE.

I also agree to conduct myself in a sportsmanlike manner prior to, during, and after the COURSE and while I am in the vicinity of the COURSE. I will not engage in any surfing activity, unless authorized to do so, during the duration of the COURSE and will at all times comply with the instructions and safety procedures of the COURSE. I understand that failure to comply with these requirements may result in my disqualification and removal from the COURSE.

### Photography permission

I assign to Cressey's Surf Academy the use of all photographs and film for the purposes of promoting the work of Cressey's Surf Academy. I agree to my photograph being taken and to being filmed and used in publicity for Cressey's Surf Academy promotional publicity material.

### Assumption of Risk
